ONE WARM COAT PROVIDED 472,956 FREE COATS TO CHILDREN AND ADULTS IN NEED THROUGH A NETWORK OF 1,500 NONPROFIT PARTNERS THROUGHT THE UNITED STATES. THE NONPROFIT PARTNERS DISTRIBUTED GENTLY WORN COATS THAT WERE COLLECTED THROUGH 4,624 COAT DRIVES ACROSS THE COUNTRY, AS WELL AS NEW COATS AND OTHER OUTERWEAR ITEMS THAT WERE DONATED BY MANUFACTURER AND RETAILERS THROUGH ONE WARM COAT'S ZERO WASTE INITIATIVE. ONE WARM COAT'S COMBINED PROGRAMS KEPT ALMOST 1.2 MILLION POUNDS OF CLOTHING OUT OF LANDFILLS LAST YEAR.
